Bid for Taxis requirement

Eligibility:-

- 1. The Bidding agencies must enclose document regarding GST, PAN and Income tax return of last 03 financial years.
- 2. The Bidding agencies should write Name of the Company, Address of the Company and Contact Number on the Bid Cover.
- 3. The Bidder must ensure that Bid Document will be submitted in two bid system i.e. Technical and financial in a separate cover with proper citation.
- 4. The Bidding Agencies must be registered in Tourism Department, Govt. of Bihar.
- 5. The Bidding Agencies must have experience of 15 years and above with State govt. / Central Govt. / State PSU/ Central PSU and other govt undertaking.
- 6. The Bidding Agencies Must posses ESIC, EPF and Turn over not less than 50 lacks.
- 7. The taxis should be of the model not before than 2019.
- 8. The vehicle should be in Good condition mechanically.
- 9. The Body of the vehicle should be well maintained.
- 10. The interiors of the taxi should be well kept and clean and wellmaintained.
- 11. The Taxi should have commercial license.
- 12. The driver should have commercial/professional Driving license.
- 13. The vehicle should have commercial Insurance covering passengers and third party besides, driver and Vehicle.
- 14. The Bidding agencies will have to submit a security deposit of Rs. 50,000/- in form of D.D.
- 15. Demand draft should be in the Name of DDO Bihar Legislative Council Secretariate, Patna.
- 16. The Bid and D.D. should be submitted on the address:-

Director, Bihar Legislative Council Secretariate, Patna.

- 17. The Last date of receiving the Bid document is 25.09.2023 till 01:00 P.M. No Bid will be entertain after the stipulated time.
- 18. The Bid will be opened 25-09-2023 at 04:00 P.M. in the Chamber of Secretary where representative of Bidding agencies can be present.
